The experience of the regulator is key and their understanding of the industry helps enable an appropriately regulated environment for simple and extremely complex structures.

The Financial Intelligence Agency was formed to investigate suspicious activity and works with the BMA and the Bermuda police to prevent and detect financial crime and to protect Bermuda's reputation.

The Caribbean Financial Action Task Force has assessed Bermuda's regulatory regime as being very effective in the fight against money laundering and terrorist financing.

Innovative legislative and regulatory developments implemented over recent years have invigorated Bermuda's asset management and private equity industries and created a highly responsive capital market for investors. Globally distinguished service providers operate within a technologically sophisticated, easy-toaccess infrastructure.
