Assets traded by NRIs must be registered, kept in custody or maintained in a deposit account in a financial institution, or properly maintained in systems prepared to handle registration, settlement, and custody, acknowledged by the Brazilian Central Bank, or authorised by the Brazilian Securities and Exchange Commission.
